State Chamber Announces Major Legislative Priorities, New Leaders

he State Chamber recently announced its top legislative priorities for the 2010 legislative session. State senators reconvened January 6, which marked the start of the 60-day "short session" of the two-year legislative period.

Last month, the State Chamber's board of directors also elected the association's executive leaders for 2010. Richard S. Reiser, Executive Vice President and General Counsel of Werner Enterprises, Omaha, began his duties as State Chamber Chairman on January 1. Reiser succeeded Marc LeBaron, Chairman and CEO of Lincoln Industries, Lincoln. Jeffrey M. Scherer, CFO of Smeal Fire Apparatus Co., Snyder, serves as Chairman-Elect.

As approved by its board of directors, the State Chamber's 2010 major legislative priorities include:

• Reducing Tax Burden. To create new jobs and economic growth, the State Chamber believes Nebraska's tax climate must become more attractive. Specifically, Nebraska's corporate and individual income tax rates need to be more competitive nationally. The State Chamber also supports initiatives to improve efficiency in government, while opposing further broadening of the state's sales and use tax.

• Expanding Economic Development. The State Chamber supports review and enhancement of Nebraska's

targeted job and investment incentive programs, such as the Nebraska Advantage, to ensure the state is competitive in attracting new jobs and retaining current employers. To ensure an adequate number of skilled employees, the State Chamber also supports workforce-related educational programs and customized job training efforts.



equate Highway Funding. As funding for new road construction becomes tighter, the State Chamber supports the preservation of the state Highway Trust Fund and opposes efforts to divert funds for other purposes.

- <u>Protecting Nebraska's Right-to-Work Guarantee</u>. The State Chamber supports Nebraska's Right-to-Work constitutional guarantee and opposes efforts to weaken it.
- Reviewing Workers' Compensation & Unemployment Programs.

 Because employers pay the full cost of workers' compensation and unemployment insurance, the State Chamber recommends continued legislative

review and implementation of reforms to avoid significant cost increases.

• Ensuring Affordable Health Care
Coverage. Because health care costs continue to be a top concern for employers, the State
Chamber opposes any legislation that would negatively impact the affordability and availability of group insurance, including

affordability and availability of group insurance, including mandates requiring coverage beyond federal standards.

recently read a book entitled "Bowling Alone," which documented the dramatic reduction in members belonging to many state and national organizations.

They have also formed a Career Dream Team to highlight the opportunities in manufacturing careers.

 Fair for the first time. The development occurring in Grand Island, coupled with new business activity recently announced, create a high level of optimism for the future of central Nebraska.
- Lincoln has the new Innovation
 Park to fill technology opportunities that
 will create 21st century jobs which will
 allow Nebraska to keep more of its
 talented young people here. The 2015
 Vision project is creating the foundation
 to assure Lincoln's ability to grow for
 the future.



State Chamber Urges Congress To Pass Long-Term Highway Bill

he Nebraska Chamber of Commerce & Industry has joined other leading business organizations around the nation in calling on Congress to approve a robust, six-year federal surface transportation program authorization. The nation's highways and public transportation law, known as SAFETEA-LU, expired in September, and surface transportation programs have been operating on a series of short-term extensions ever since. Short-term extensions mean less money is available for states and do not provide states the certainty they need to keep crucial transportation projects moving forward.

The letter co-signed by the State Chamber, which was delivered to Capitol Hill in December, stated: "Unlike much government spending, strategic capital investments in our national highway, bridge and public transportation network provide long-lived assets that return value to American families, businesses and the U.S. economy for current and future generations – value far exceeding their initial cost."

State Chamber Opposes Senate Health Bill

Several Nebraska business and agricultural organizations – lead by the State Chamber and the Nebraska Farm Bureau – recently noted their strong opposition to the federal health care bill moving through Congress. In a joint letter to U.S. Senators Ben Nelson and Mike Johanns, the coalition urged both senators to vote against a motion to bring the bill to the Senate floor, as well as an expected motion to halt debate on the legislation.

The coalition voiced support for market-based reforms, opposing any form of a government-operated health insurance program. The group also expressed deep concern over the numerous tax increases included in the health care bill.

Also signing the letter were Nebraska Cattlemen, Greater Omaha Chamber of Commerce, Bellevue Chamber of Commerce, Grand Island Chamber of Commerce, Columbus Chamber of Commerce, Fremont Area Chamber, Scottsbluff/Gering United Chamber of Commerce, and Cheyenne County Chamber of Commerce.

Nominations of outstanding Nebraska business leaders should be sent to the State Chamber office. The main criterion is that the individual has made a significant contribution to Nebraska's private enterprise system.

They are: **Abe Baker** of Omaha, Baker's Supermarket; **Joe Hampton** of Lincoln, Hampton Enterprises; **C.G.** "**Kelly**" **Holthus** of York, Cornerstone Bank; and **John Nelson** of Omaha, SilverStone Group.
