### Washington Meetings Set for May 9-11

The annual State Chamber Congressional visit to Washington will be on May 9-11, 2005. As in past years, we will hold a luncheon at the Hart Senate Office Building on Tuesday, May 10, where members of the Nebraska Congressional delegation and their chief staff members will join us. On May 9, we will attend an Issues Briefing at the U.S. Chamber of Commerce headquarters in the afternoon. On Tuesday morning, we will have an Issues Briefing at the National Association of Manufacturers (NAM), followed by the Congressional Luncheon. Attendees may attend the Nebraska Breakfast at 8:00 a.m. on Wednesday, May 11, in the Dirksen Office Building cafeteria.

This year, we have made arrangements with the Holiday Inn On The Hill for lodging. The Holiday Inn is two blocks from the U.S. Capitol and Union Station, and the Metro. We have a block of rooms with rates of \$205 per night. Please contact Vice President—Public Affairs Don Mihovk at the State Chamber to make your room reservations. The cut-off date will be April 18.

President Bush is promoting a number of issues of concern to business, including making tax cuts permanent, class-action reform, asbestos litigation, energy, trade, and transportation. The Senate make-up is slightly more conservative, and there may be more opportunities for legislation to be passed as opposed to being bottled up as in past sessions. Our representatives need to hear your concerns and the Washington visit is an excellent opportunity for face-to-face meetings.

# 2005 Annual Meeting Highlights

he State Chamber's Annual Meeting and Legislative Caucus was held on February 3 at the Cornhusker Hotel and Conference Center in Lincoln. Governor Dave Heineman addressed the luncheon, which honors the local chambers of commerce across Nebraska and kicked off "Nebraska Chamber of Commerce Month." Governor Heineman outlined his priorities for holding the line on spending and his priorities for this session.

The afternoon sessions featured the traditional Legislative Panel to bring members up to date on key business issues before the 2005 Unicameral. Four legislative chairmen gave members their perspective on the Session. Members also attended two excellent afternoon programs dealing with "Surviving and Growing in the New World Economy — A Business Perspective" presented by Todd Johnson, Executive Director, Global Initiatives, the Gallup Organization. The other program "The Next Generation of Economic Development Tools" featured Revenue Committee Chairman Senator David Landis and Economic Development Director Richard Baier.

# "It Is Now Reality"

hether or not you support or oppose term limits is irrelevant — it is a political reality for Nebraska legislators

There are several legislative resolutions being debated this session that would give the voting public an opportunity to revisit the issue. The proposals range from total repeal of term limits to extending the length of service to three four-year terms and also providing for a recall process. Under any of these proposals, the earliest scenario would be to vote on a plan in 2006.

A more pressing issue is the recruitment of good candidates to run in 2006. Currently, 20 State Senators will not be allowed to stand for reelection. Losing that much institutional knowledge in one fell swoop is indeed going to be a tremendous adjustment to the legislative process. Then in 2008, Nebraska will lose at least another 17 "veterans" of legislative service, meaning that at least 37 of the 49 current State Senators will not face the electorate for legislative office.

# The issue of our time is, "Who will step forward and run for the Legislature in 2006?"

Enclosed with this *Executive* is a copy of legislative districts that will be open seat districts in 2006 and the names of those State Senators that will not be allowed to run again.

People who live or work in these districts need to seriously think about running themselves or encouraging a viable candidate they know and trust to run.

Fifteen of the 20 who cannot run carry a career cumulative support record of 85.6% on the State Chamber's annual voting record,

meaning they voted with business about 7 out of 8 times. This level of support does not happen by accident, but only when constituents stay in close touch with their elected officials, making sure they understand how legislative issues affect a firm's ability to stay in business and prosper.

Please take a close look at the list of "open seat districts." The State Chamber, and many other business associations, want to start meeting immediately with people who you think deserve support from the business community. We cannot simply sit back and hope that good candidates will surface.

Now, more than ever before, we must be tremendously pro-active in seeking out and encouraging qualified people and obtain the resources to run an effective campaign.

Participants will meet at the State Capitol at 9:00 a.m. The program will include updates from members of the Legislature and other state leaders. Mailings to members of the Council will go out later this month to detail locations.

All you have to do is click the web address at the bottom of the email message we send you; or in the case of a fax message from us, you can type into your browser the web address you will find on the fax.

The first time you go to the Grassroots Action Center, you will have to register. On subsequent visits, your login will be quicker. You will also be able to view our Active Issues and send messages through our website at <a href="https://www.nechamber.com">www.nechamber.com</a> by clicking on our Grassroots Action Center. 
