he first meeting of the State Chamber's Leadership Nebraska Class II was held February 6-8 at Mahoney State Park. The class' 23 members participated in an Orientation Session that featured presentations by members of the inaugural class; an interactive presentation by Lincolnbased Talent Plus staff; a talk on "Leading Through Giving" by Lyn Wallin Ziegenbein of the Peter Kiewit Foundation; a discussion on Nebraska history by Dr. Bob Manley; a keynote speech on "Leading Nebraska Through a Continuum of Change" by futurist Ed Barlow; and another interactive

presentation on "Great Leaders In Changing Times" by Cy Wakeman.

The Leadership Nebraska program is aimed at persons who have demonstrated community and professional leadership experiences. The program provides six sessions per year to give class members an opportunity to develop and hone leadership skills and gain a broader understanding of issues facing Nebraska, according to Bob Harris, chairman of the State Chamber's Leadership Nebraska Council. The alumni of each Leadership class will conduct an ongoing

series of meetings and programs to strengthen relationships developed and to maintain and enhance the knowledge gained during their Leadership experience.

The remainder of the 2008 Leadership Nebraska program will

feature sessions on the following state issues: Public Service (early March); Education (late April and early May); Economic Development (late June); Agriculture (early August); and Healthcare/Human Services (in September). A commencement ceremony will be held October 24, 2008.

State Chamber Views... Editorial by Barry L. Kennedy President, Nebraska Chamber of Commerce & Industry

"The Obstacles Of Growth"

n the last issue I wrote about pending legislation that would allow Nebraska to be more competitive in job creation and economic growth. Unfortunately, there is also pending legislation that would install substantial obstacles to Nebraska's ability to grow our economy. In this month's article, I will spotlight specific proposals that would be counterproductive to business growth.

UNEMPLOYMENT INSURANCE

Many people do not realize that employers pay the FULL costs of both unemployment insurance and workers' compensation for their employees. Benefits in Nebraska are fair, but not exorbitant. Nebraska is also very fair when it comes to qualification standards.

Currently, an individual's weekly unemployment benefit is one-half of his or her average weekly wage, but capped at the lesser of 50 percent of the state average weekly wage or the previous year's maximum weekly benefit amount, plus \$10 per week. LB833 is a proposal that would significantly increase benefits. If LB833 were to pass, by the year 2013 and thereafter, the benefit amount would be 75 percent, not to exceed 100 percent of the state average weekly wage. That would mean the maximum weekly benefit amount would increase from the current \$298 per week to \$642 per week, according to the Nebraska Department of Labor. Businesses would have to pay more than \$34 million per year, assuming the current insured unemployment rate.

WORKERS' COMPENSATION

Another bill introduced this year would cover employees' mental injuries resulting from having viewed violent acts deemed extraordinary or unusual. If enacted, LB1082 would also cover state employees, and state officials estimate that the additional cost to the state alone would be between \$4 and \$26 million per year just for state employees. Studies have shown that the cost of mental illness claims is about 50 percent more than the average claim for a traumatic injury and that mental injury claims are paid over a longer period.

HEALTH INSURANCE MANDATES

Each year, bills are introduced to mandate additional coverages to employer-provided health insurance programs. An argument can be made regarding the benefit of each one, but each one also adds to the cost of providing health coverage. The State Chamber has had a long-standing position that opposes any legislation that mandates minimum standards for health insurance coverage exceeding federal ERISA requirements. We will continue to oppose initiatives that would place an additional burden for health care finance on employers as well as employees.

RIGHT-TO-WORK

Nebraska is a "Right-to-Work" state. That tenet is embedded not ONLY in statute, but in our state's constitution. Many economic development consultants will testify that when employers are looking to either expand an existing plant location or cite a new plant location, Right-to-Work is one of the key items they take into consideration when making that decision.

Each year, however, we see a bill introduced that would require employees to pay a fee to a union for representation regardless of whether they are a member of that union or not. Under federal law, a union

chooses whether or not to represent all of the employees in a workplace. Most do choose to represent them in hopes that they are able to attract new members, but this legislation would force payment from employees who have chosen not to belong.

The State Chamber supports the principle of voluntary union membership and Nebraska's Right-to-Work guarantee. We will oppose any effort to repeal or weaken in any way that constitutional protection.

These are just four issues of interest. There are several other tax measures and many regulatory efforts proposed that would be onerous to your ability to grow and prosper in our state. We are now just over the halfway mark for the 2008 legislative session, and we will continue to be ever vigilant in our work to protect your interests. Small Business Day At The Capitol

Governor Dave Heineman delivered the keynote address for Small Business Day at the Capitol on February 20. The event, attended by nearly 40 Nebraskans, was hosted by the State Chamber's Small Business Council, in cooperation with the Nebraska Federation of Independent Businesses (NFIB), the Lincoln Independent Business Association, and the Lincoln and Omaha Chambers of Commerce. Attendees of the event also heard from State Senators Chris Langemeier of Schuyler and Deb Fischer of Valentine, regarding legislative proposals before

the Unicameral's Revenue and Transportation Committees. State Chamber President Barry Kennedy and NFIB/Nebraska Director Bob Hallstrom provided insider information and briefed attendees on the key legislation of importance to the state's business community.





State Chamber-PAC Proves Important In Election Year

This year marks the second consecutive election cycle in which Nebraska's new term limits law will have a significant impact. In 2008, 15 state senators are term limited. An additional 10 state lawmakers are seeking re-election, while another – who was appointed by the Governor – must run for the balance of the term. In total, there are 26 legislative races this year.

Needless to say, this will be another busy year for the State Chamber's Political Action Council (PAC), which serves as the separate political arm of the Nebraska Chamber of Commerce & Industry. The PAC is comprised of State Chamber members from across Nebraska – people who are interested in electing business-

oriented representatives to the Legislature. It is a non-partisan, voluntary collection of citizens who support the state's employers and want them to be able to prosper.

Supported by contributions from businesses and individuals, the PAC is administered by the Political Action Council of the State Chamber.
Throughout the election cycle, either professional or volunteer leadership of the State Chamber meets with candidates who are seeking a legislative seat. Recommendations are typically forwarded to members of the Political Action Council, which can approve political contributions to candidates and their campaigns.

"In an active election cycle, such as this year, the State Chamber-PAC

demonstrates its worth quickly," said State Chamber President Barry Kennedy. "Electing the right people to Nebraska's Legislature is the most effective way to ensure your business interests are recognized," Kennedy added. He added that no State Chamber dues investments are ever used for political contributions.

It would be difficult for any single business or individual to provide the type of candidate support provided by the PAC. Through the PAC, political investments are consolidated with those of other businesses and individuals from across the state, ensuring that each donation has a more dynamic impact on key legislative races.

They were escorted onto the floor of the George W. Norris Legislative Chamber to watch the Legislature conduct business.

Governor Plans 'Reverse Trade Mission' For September

Governor Dave Heineman plans to host international guests from several countries September 10-13 as part of what he is calling a "reverse trade mission." The reverse trade mission is aimed at encouraging international companies to explore opportunities for investment in Nebraska. It is anticipated that representatives from Japan, China, Brazil, and Germany will be among those participating. And any international company interested in doing business in Nebraska is invited to participate.

More than 350 businesses in Nebraska are foreignowned and employ more than 19,000 workers. Overall, international trade is responsible for sustaining more than 56,000 jobs in the state and creating more than \$5 billion in new revenue each year. According to the governor, the event will offer trade representatives and international business contacts the opportunity to see firsthand the benefits of doing business in the state. Events associated with the reverse trade mission will be held in several communities and will highlight several of Nebraska's growing industries, including: renewable energy, agriculture, distribution and logistics-oriented companies, medical research, and information technology, as well as the finance and insurance industries.

The event is being sponsored by the Nebraska Diplomats and the Nebraska Department of Economic Development and Agriculture. Trade mission participants will be invited to take part in the annual Nebraska Diplomats' Passport to Nebraska Weekend, planned for September 12-13. ■
