## State Chamber Goes To D.C.

he State Chamber's annual visit to Washington, D.C. was held April 22-23. Twenty State Chamber members attended the three-day function, which included the weekly Nebraska breakfast on Capitol Hill, as well as policy briefings from the U.S. Chamber of Commerce and the National Association of Manufacturers (NAM). Topics included energy policy; the "card check" bill addressing labor union organization; immigration; foreign trade agreements; and possible changes coming to the Family Medical Leave Act.

Highlights of this year's visit included a congressional luncheon with Nebraska's senators, congressmen, and their staffs. Sponsored by the Nebraska Public Power District, the luncheon allowed the opportunity for State Chamber members to hear directly from Nebraska's congressional delegation on issues affecting the business community. Participants also were treated to an evening reception at the Washington offices of Husch Blackwell Sanders LLP, where participants visited with congressional staff members from Nebraska.

At the Nebraska breakfast, State Chamber members heard from Senator Ben Nelson and Representatives Lee Terry, Jeff Fortenberry and Adrian Smith. Later that day, State Chamber members had a private meeting with Senator Chuck Hagel. The congressional delegation provided thorough updates on key legislation pending in both the Senate and House of Representatives.

## "Take Time To Educate Candidates, Senators"

mplementation of Nebraska's legislative term limit law is making a dramatic turnover of state senators in Nebraska. There were 22 new senators elected in 2006, and there will be at least 15 new senators elected this November.

This high turnover rate can be viewed as a challenge. The process of getting to know each of the newly-elected senators and making sure they understand the issues that affect your ability to grow and prosper in Nebraska certainly takes more time and effort.

On the other hand, a high turnover rate in the Legislature can be an opportunity if you are willing to work toward educating new Senators about your business and the impact you have on your employees and community.

Let me suggest that this challenge and opportunity can be met by doing the following:

1. Take time to meet with the candidates in your area and the newly-elected senators to explain to them why it is important to support business-friendly issues. If they are not already familiar with your operation, explain to them what government-imposed cost and regulations concern you most.

They may, or may not, fully understand the impact of taxes, health care cost, unemployment cost, workers' comp cost and all the other compliance issues that you face while trying to keep your business competitive and growing.

2. Invite them to visit your place of business. Whether you are a manufacturer, a service provider, a financial institution, construction company, communication specialist, retailer, medical services provider, transportation company, wholesaler, educational services or one of the many other types

of companies that make up Nebraska's business community, elected officials need to have your input.

Be sure to walk them through your facility so they see firsthand what exactly goes on within your business. Let them meet and visit with some of your employees so they know the kind of jobs you have created in your area. Inform them of any benefits that you provide for your valued employees. Things like health care coverage, continuing education and training opportunities, and leave and vacation policies that are not mandated by state or federal government.

When elected officials truly understand the obstacles that face your business on a day-to-day basis, they can then better represent your interest as those issues arise.

In addition, when they know firsthand that you are being a good corporate citizen and trying to provide quality career opportunities and a safe work environment for your employees, they will be less likely to over-react when stories of bad actors cause an onerous piece of legislation to be introduced.

Elected officials have a responsibility to make an effort to obtain as much factual information about an issue as possible before making an informed vote on that issue. As employers in Nebraska, we also must accept a responsibility to make every effort possible to assure they understand our positions and have factual information.

The best way to accomplish this is by developing a personal relationship with our policy makers during their campaign and maintain it throughout the time period they serve in a particular office. When you need to contact a seated senator about an issue of importance to you, it is always easier to talk to someone you know, than it is to someone you don't know. It is also easier for them to understand your position if they are familiar with your operation.

Please consider taking some time to invite a candidate or elected official to tour your business and to show them firsthand your concerns and what you are trying to do to sustain good jobs in your community. You have nothing to lose, and the benefits could prove significant for both you and Nebraska's business economy in general.

## Senators, Governor Approve LB888, LB895

State Chamber members and staff took part in signing ceremonies for two important pieces of legislation enacted this session. The first bill, LB888, provides tax relief to Nebraska corporations by raising the threshold of the state's higher corporate tax bracket, from \$50,000 to \$100,000. LB888 was sponsored by Senator Carroll Burling of Kenesaw and prioritized by Senator Scott Lautenbaugh of Omaha. The other key piece of legislation, LB895, is known as the Nebraska Super Advantage. Prioritized by Senator Tim Gay



of Papillion and introduced by Senator Ray Janssen of Nickerson, LB895 provides new incentives to companies that create high-paying jobs. Both bills were priority measures for the Nebraska Chamber of Commerce & Industry. Pictured above is State Chamber President Barry L.
