## "The Value of Belonging To The State Chamber"

usiness in Nebraska is looking good. Earlier this year, a well-known nationwide study – the Pollina Corporate Survey – ranked Nebraska in its top ten of pro-business states. This year is the first time that Nebraska has ever appeared in the Pollina survey's top ten.

The good news continued when Governor Heineman announced that 116 companies have applied for incentives under the state's business incentive plan – known as the Nebraska Advantage. More than 10,000 new jobs and more than \$4 billion in investments could come to our state due to the Nebraska Advantage Act, which was strongly supported by the State Chamber after its introduction in the Legislature in 2005.

Nebraska's business climate and competitiveness ranking are improving rapidly, and the State Chamber wants to see these trends continue.

With 95 years of experience under our belt, the State Chamber is Nebraska's largest statewide business association – representing individuals, large and small companies, other associations and local chambers of commerce. We are not a charitable organization – we are a business trade association that provides a valuable service for a fee. Our members hire us to look out for their interests and the state's business interests.

One of our highest priorities is monitoring and lobbying Nebraska's Unicameral on issues that affect business growth and profitability. We know that most employers simply do not have time to stay abreast of all the proposed rules, regulations, laws, procedures and other issues that affect their bottom line. That is why we work hard to promote, encourage and protect all aspects and elements

of Nebraska's free-enterprise system.

Whether it is labor law, tax policy, economic development, health insurance mandates or federal trade policy, your State Chamber strives to make your views known to the elected officials who make decisions impacting your business and your community.

Another key to our success is our relationship with local business leaders. Nebraska is extremely fortunate to have a network of strong local chambers of commerce. Each one has a dynamic impact on the community and area it serves.

We know the professional staff of Nebraska's local chambers work extremely hard to carry out the directions set by their leadership – and the continued growth of our state economy depends heavily on their efforts. Without our local chamber leaders, it would be difficult to accurately gauge the pulse of our state business community. That is why we place a heavy emphasis on our relationship with local chamber leaders.

It is difficult to put an exact dollar amount on the value of a State Chamber membership. But our long list of recent legislative accomplishments indicates that State Chamber members definitely get their money's worth.

For example, the 2007 legislative session saw the passage of a \$420 million tax relief package – the largest tax cut in state history. The state estate tax was repealed. The sales tax on commercial construct labor was abolished. Another \$10 million was dedicated to the Nebraska job training program. Important pro-business bills addressing workers' compensation hospital fees and sick leave benefits were approved and signed into law. And threats to the state's right-to-

work guarantee were blocked.

The State Chamber played an active role in all of these initiatives. We are proud of these accomplishments.

But like most businesses, the State Chamber's work never ends. Next year brings a new legislative session; once again, we will be vigilant in serving your interests.

Several individuals and organizations were honored at the banquet, as awards were presented by Governor Dave Heineman. The Ambassador Plenipotentiary Award — the highest Diplomat honor — went to Blair State Senator Mick Mines, who has been a member of the Legislature's Banking, Commerce and Insurance Committee since 2003 and chaired the Committee from 2005-2006.

The Diplomat of the Year went to Jack A. Schreiner, president of Bruckman Rubber Co. in Hastings. As a Nebraska Diplomat, Schreiner has worked hard to promote Nebraska businesses with Japanese and Taiwanese companies interested in doing business in the U.S.

Fremont received the Community of the Year Award. The city recently yielded location and expansion projects totaling nearly \$70 million and creating 500 jobs.
