Dear NE Chamber Members:

Growing states are surviving and thriving states, and Nebraska is bulging at the seams. That's why we were laser-focused on policies that accelerate our state in the 2023 Nebraska legislative session. We're proud to report some critical results for business this year, including:

- Opening up opportunity with transformational tax relief;
- Fueling research and development investment;
- Driving growth in workforce recruitment and retention; and
- Empowering local communities.

For the past five years, NE Chamber members have been telling leaders in no uncertain terms what barriers their organizations and communities are facing on their road to growth. We're fortunate to have a class of leaders who have largely been responsive to our members.



We're one lap in to the Nebraska Legislature's two-year cycle. It's a good time to evaluate how far we've come and the opportunities that lie ahead.

Transformational Tax Relief

The culmination of our work has historically lied in tax reform — transforming Nebraska from a high- to a low-tax state. We've always known that when we relieve tax burden on Nebraska's makers, producers, and family businesses, we unleash growth — in our economy, jobs, quality of life and ultimately, population.

Years of hard work have paid off. From 2015 through 2029, Nebraska leaders will have enacted more than \$21 billion in tax relief and cuts, \$14.7 billion of which is dedicated to property tax relief.

By 2027, most Nebraskans and their employers will be enjoying a 3.99% income tax rate. Schools will see enhanced state funding, and Nebraskans will have received an extra \$3 billion in property tax relief.

In addition to transformational tax relief, we made strides in addressing several other critical and emerging needs for Nebraska business.

- Promote tech-enabled manufacturing
- Enhance industry-education partnerships
- Launch economic competitiveness studies by the NE Chamber Foundation
- Graduate another class of strong community and state leaders
- Roll out Tech Nebraska to support tech-forward policy and statewide workforce
- Lead state and national coalitions to make the case for legal immigration reform
- Collaborate to boost college enrollment by 10%
- Expand use of workforce development funds for talent retention
- Extend Nebraska's Research & Development Tax Credit
- Create the first childcare tax credit for private entities
- Invest millions more in career and technical education
- Cut red tape in rural and middle-income housing programs

There's no stopping - we're only accelerating from here.


MODERNIZE TAXES

RESULTS

- ✓ Individual and corporate income tax rates will drop to 3.99% for most Nebraskans.
- ✓ All types of businesses will pay the same tax rates – parity.
- Property tax relief mechanisms will stay intact and be expanded.
- Key sales and use taxes are being modernized to meet evolving market needs.
- Military, federal and social security income exemptions will all be effective in 2024.

Between 2015 and 2023, Nebraska legislators had adopted **\$21.2 billion** in tax relief to be fully realized by 2029.

The highlight of those cuts for Nebraska's businesses is an across-the-board reduction in the top two individual and corporate income tax rates to **3.99% by 2027** – an acceleration and expansion of 2022 tax cuts. By 2029, Nebraska should be at or near the **top 15** states with the most competitive tax rates.




*Top two tax brackets (2023) — Individuals earning \$22,170+; Married earning \$44,350+; Corporations earning\$100,000+.

Tax Results

Income Tax (LB754*/AM1405*)

Reduces top two individual and top corporate income tax rates in phases to 3.99% by tax year 2027; allows partnership taxpayers to pay income tax directly to the state on amended returns rather than pass through tax liability to its partners; exempts military, federal and social security income starting in tax year 2024.

Amendment 1405, which was defeated, proposed lesser tax cuts and higher bracket-based rates.

Property Tax (LB243*/LB818)

Increases funding for refundable income tax credit for property taxes paid to \$1 billion and removes 5% allowable growth cap; places caps on school district tax levying authority without a public vote; phases out levying authority for community colleges while increasing state budget allocations; adopts Tax Equalization and Review Commission changes to help expedite appeals or reduce taxpayer costs during long appeals.

Sales & Use Tax (LB727*)

Offers an income tax credit for food donations; creates a biodiesel tax credit for retail dealers.

Both the Governor and Revenue Committee have signaled an interest in addressing increasing property valuation costs.

State and Local Taxes (LB497)

Restores itemized deductions for state and local taxes (SALT)

Opposed & No Action in 2023

Consumption Tax (LB79)

A constitutional amendment for the 2024 ballot that repeals income, sales and property taxes and replaces them with a statewide retail consumption tax.

RESULTS

- **Businesses can apply for workforce** development funding, not only for recruiting and training workers, but also retaining talent.
- An extra \$10M in workforce recruitment and retention grants is available.
- Middle and high school students will benefit from more than \$5M in state funding for career and technical education.
- Students in high-demand fields are eligible for \$40M more in scholarships through 2025.
- Refugee immigrants can more easily travel between work and home.

After tax relief, Nebraska leaders turned to the next top priority of Nebraska businesses - workforce.

In total, they made a \$55 million commitment to workforce development through new recruitment and retention grants, career scholarships and career and technical education (CTE).

They also created a path for Nebraska's refugee immigrants to apply for state driving privilege cards.

Workforce Results

Workforce Training & Support (LB191*)

Allows the Nebraska Training and Support Cash Fund to be used at Nebraska businesses for retention of existing employees in addition to training and recruitment already permitted.

Workforce Development Grants (Budget)

\$10M to support the workforce development needs of Nebraska employers, including apprenticeships, internships, hiring incentives, job training, credentialing, certification and educational stipends.

Career & Technical Education (LB610/Budget)

\$5M in state funds in addition to federal funding to support successful career and technical education programs in Nebraska's middle and high schools.

Career Scholarships (Budget)

About \$20M annually through 2025 to Nebraska community colleges and private, nonprofit colleges to offer scholarships to students in high-demand fields. The program previously received a \$3M allocation.

Refugee Driving Privileges (LB138/AM837*)

New refugee immigrants in Nebraska under legal, federal authorization may obtain a state driving privilege card. AM837 added the measure to the LB138 onmibus legislation.

Child Care Tax Credit (LB754*/LB318)

\$15M annually in refundable income tax credits for families; \$7.5M for the School Readiness Tax Credit for childcare providers; \$2.5M in nonrefundable tax credits for private contributions to childcare.

Workforce Housing (LB249/LB191*/LB629/LB531)

Expands eligibility for both the Rural Workforce Housing and Middle Income Workforce Housing matching grant programs.

Higher Education Funding (Budget)

1.9% - 2.5% budget growth, partially to help expand student enrollment initiatives.

Remote Worker Taxation (LB416)

Exempts non-resident remote worker income from Nebraska taxes until a de minimums threshold is met.

Federal Legal Immigration Reform

Effectively and legally addresses our workforce shortage by maintaining effective border security, reforming and expanding work visa and temporary worker programs, and expanding legal immigration quotas.

Unemployment Eligibility (LB618)

Make work-authorized aliens eligible to receive the unemployment benefits currently being paid by employers.

RESULTS

- Nebraska's R&D Tax Credit remains intact through 2033.
- All manufacturers receive the same tax exemptions for equipment and facility upgrades.
- ✓ The legislature is studying the economic impact of manufacturing modernization to inform future action.
- Large, high-tech projects have the matching funds or access to economic incentives needed to locate in Nebraska.

Nebraska's **capacity to innovate** in a fast-paced global economy with a shortage of available talent is critical to long-term growth.

Nebraska leaders embraced this need by extending the state's research and development tax credit and ensuring sales and use tax exemptions for facility improvements extend to manufacturers of all sizes.

They also paved the way for attracting major high-tech projects to Nebraska, such as next-generation hydrogen hub and semiconductor manufacturing clusters.



How does this affect my business?

- Factor the state's additional tax credits into your modeling if you are considering product enhancements or new product development.
- Planning equipment or facility upgrades? Your project may be eligible for sales and use tax exemptions, even when third-party contractors do the purchasing.
- A high-tech megaproject in Nebraska could attract new technology, skilled talent and high-paying jobs to propel economic growth.

Innovation Results

Nebraska Advantage Research & Development Tax Credit (LB727*/LB491)

Sales and use tax refunded or refundable income tax credit at 15% of federal R&D tax credit or 35% when partnering with a Nebraska college or university. Extended through 2033.

Sales & Use Tax Exemptions for Real Property Improvements (LB727*/LB74)

Extends sales and use tax exemptions to qualifying purchases for real property improvements when third-party contractors act as purchaser.

Semiconductor Manufacturing (LB92*/LB616/LB617)

Appropriates \$20M into the Nebraska Economic Development Cash Fund to attract a Creating Helpful Incentives to Produce Semiconductors (CHIPS) for America Act project and makes such projects eligible for Nebraska's mainline economic incentive program.

Hydrogen Hub (LB565/LB568)

Allocates \$500K in grants for engineering and modeling that supports the state's application to become a U.S. Dept. of Energy regional clean energy hub. Establishes a working group to determine nuclear and hydrogen sector workforce needs.

Precision Agriculture Infrastructure Grants (LB361/LB814)

Appropriates \$2M for grants incentivizing precision agriculture connectivity, sustainability, traceability, and autonomy.

Manufacturing Modernization (LR123)

A resolution introduced by the Legislature to study the economic impact of manufacturing automation and high-tech industry.

Insurance Regulatory Sandbox Act (LB587/LB814)

Allows temporary testing of innovative insurance products or services without otherwise being licensed or authorized to act under the laws of the state.

In Progress

Manufacturing Modernization Tax Credit Support (LB582)

Creates a targeted, pilot grant program that aids the smallest to largest manufacturing employers across the state through technology transformation.

Tax Cuts and Jobs Act Amortization Schedule for Research and Experimentation Expenses (LB492)

Decouples state amortization schedule from the federal structure for R&E expenses, effectively extending that portion of the Tax Cuts and Jobs Act in Nebraska. (*Pursuing parallel effort in U.S. Congress*)



RESULTS

- Nebraska's new childcare tax credit will help support working families.
- Less red tape in workforce housing and broadband programs, plus expanded eligibility.
- Communities gain flexibility in executing redevelopment plans.
- Public-private partnerships can better fuel growth in childcare, transportation and water infrastructure.

More than ever, attracting and retaining talent is closely tied to each community's ability to attract, accommodate, and retain new residents and families.

This year, legislators helped empower communities with targeted action in local housing, childcare, healthcare, broadband, and recreation solutions.

They created the state's first childcare tax credit, paved the way for more public-private partnerships to address workforce needs, and cut red tape to expand eligibility of workforce housing programs. They also raised Medicare reimbursement rates for critical access hospitals and more.

- 3. Housing options may grow in your community under new eligibility and streamlined redevelopment programs.

Community Results

Child Care Tax Credit (LB754*/LB318)

\$15M annually in refundable income tax credits for families; \$7.5M for the School Readiness Tax Credit for childcare providers; \$2.5M in non-refundable tax credits for private contributions to childcare.

Expanded Childcare Assistance for Working Families (LB227*/LB35)

Extends expanded access to state childcare assistance, better allowing families to transition off the program as they advance in their careers.

Workforce Housing (LB249/LB191*/LB629/LB531*)

Expands eligibility for both the Rural Workforce Housing and Middle Income Workforce Housing matching grant programs.

Micro-TIF Streamlining (LB531*/LB98)

Allows cities to adopt expedited review of Micro-TIF (tax increment financed) redevelopment plans and approve multiple projects within one blighted area study and public hearing. Applies retroactively if desired.

Revitalize Rural Nebraska Grant Program (LB531*/LB45)

Provides \$1M for grants to demolish dilapidated commercial property in first- and second-class cities and villages.

Medicaid Reimbursement (LB227*)

Requires the state to rebase inpatient per diem rates every two years using the most recent audited Medicare cost report; offers per diem rates to hospitals when a patient awaits transfer into a nursing facility or there is no public quardian.

Broadband (LB683/LB412/LB359)

Allows opening of Broadband Bridge grants throughout the year; allows for broadband grants from the American Rescue Plan Act (ARPA) Capital Projects Fund for an entire exchange area, including a second-class city or village and surrounding rural areas.

Nebraska Highway Bond Act (LB727*/LB706)

Allows bond financing through the issuance of highway bonds to accelerate Build Nebraska Act projects and extends the Build Nebraska Act.

Water Infrastructure Construction (LB565*/LB723)

Allows alternative project delivery methods, including construction manager/general contractor, design-build and progressive design-build, and public-private partnerships to secure financing.

Shovel-Ready Capital Recovery & Investment Act (Budget)

\$90M in matching grants available for arts, humanities, entertainment and sports complex projects delayed by the pandemic.

Nebraska Job Creation and Mainstreet Revitalization Act (LB727*/LB697)

The act (Nebraska Historic Tax Credits) was extended through 2031 to support both commercial and residential downtown revitalization plans, with higher tax credits up to a \$12M cap annually.

In Progress

U.S. Highways 75 and 81 (LB212/LB454)

Requires the state to plan, design and purchase rights-of-way for full expansion of these highways from two to four lanes and appropriates funding to pave all remaining unpaved highways.

Protect Our Business Climate

How does this affect my business?

State leaders upheld Nebraska's reputation as one of the nation's **top states for business** by doubling down on their commitment to keeping regulatory burden and the cost of doing business in check.

The NE Chamber was instrumental in helping promote free markets and preserve our competitive business climate, as well as defeat proposals that threaten the economy and job creation.

Business Climate Results

Unemployment Regulation (LB191*/LB666)

Modernizes unemployment determinations of liability and combined tax rates with options for online or mailed notifications. Expands options to change elections and submit voluntary contributions.

Insurance Regulatory Sandbox Act (LB587/LB814)

Allows temporary testing of innovative insurance products or services without otherwise being licensed or authorized to act under the laws of the state.

In Progress

Wage and Hour Act Changes for Youth and Training Wages (LB15)

Sets a minimum youth wage (14-17) and a minimum training wage.

Workers' Compensation 1st Reports of Injury Confidentiality (LB191)

Protects worker confidentiality at first reports of injury.

Wage and Hour Act amendments regarding COLA Limitations (LB327)

Controls the rate of minimum wage growth to the lesser of 1.5% or CPI increases each year after 2026 (once the new minimum wage hits \$15/hour) so businesses and employers have more certainty as they plan for wage increases.

Opposed & No Action in 2023

Hazardous & Toxic Chemicals (LB7)

Institutes a 10-year statute of limitations for exposure to hazardous or toxic chemicals.

Punitive Damages (LB25)

Authorizes punitive damages and provides for distribution.

Criminal Record Checks for Employment (LB367)

Prevents employers of 15 or more from inquiring about criminal records prior to hiring unless otherwise required by federal law.

Consumption Tax (LB79)

A constitutional amendment for the 2024 ballot that repeals income, sales and property taxes and replaces them with a statewide consumption tax.

Paid Family and Medical Leave Insurance Act (LB57)

Establishes a paid leave insurance program beyond what is required by federal law.

Workplace Privacy Act (LB161)

Prevents location tracking of employees except for the purposes of contact tracing during a national emergency.

Building a Stronger Future for Nebraska through Public Policy Research

In 2023, the NE Chamber Foundation retained economic and strategic planning consulting firm, Economic Leadership, to perform three major analyses to help guide the state's economic path forward – an economic competitiveness report, an evaluation of the state's workforce needs and opportunities through legal immigration, and an assessment of the economic impact of automation in Nebraska's manufacturing sector.

In the meantime, the Foundation's Nebraska Dashboard for Economy and Workforce keeps tabs on the state's latest economic indicators – market, GDP, sector trends, population growth, wages, cost of living and more.


