

## 2004 Annual Meeting Highlights

**T**he State Chamber's Annual Meeting and Legislative Caucus was held on February 5 at the Cornhusker Hotel and Conference Center in Lincoln. Governor Mike Johanns addressed the luncheon, which honors the local chambers of commerce across Nebraska and kicks off "Nebraska Chamber of Commerce Month." He also signed a proclamation praising manufacturing in Nebraska. Governor Johanns outlined his priorities for holding the line on spending and his priorities for this legislative session.

The afternoon sessions featured the traditional Legislative Panel to bring members up to date on key business issues before the 2004 Unicameral. Four Legislative Chairmen gave members their perspective on the session. Members also attended two excellent afternoon programs dealing with "Economic Development for All Nebraska" presented by Congressman Tom Osborne, Matt Williams of the Rural Development Commission and Economic Development Director Richard Baier. Larry Bare, Governor Johanns' Chief of Staff and Legislative Fiscal Analyst Director Mike Calvert gave an update on Nebraska's budget.

Nearly 40 Senators joined about 300 members for the Annual Banquet and Business Hall of Fame induction ceremony. This year's inductees into the Business Hall of Fame were:

**Walt, Mike, and Gib Behlen** (posthumously), Behlen Manufacturing, Columbus; **Donald O. Clifton, Ph.D.** (posthumously), the Gallup Organization, Omaha; **Richard K. Davidson**, Union Pacific Railroad, Omaha; and **Henry H. "Hod" Kosman**, Platte Valley Bank, Scottsbluff.

The Banquet also saw the traditional passing of the gavel from 2003 Chairman of the Board **Gayle E. McClure** to 2004 Chairman **G. Richard Russell**.

Four \$2,000 scholarships were presented this year. The Virgil Eihusen Scholarship was awarded to David Black of Creighton University. The Jack Swartz Scholarship went to Ryan Mendlik of the University of Nebraska-Lincoln. The Affiliated Foods Midwest Scholarship was awarded to John Falk of the University of Nebraska-Lincoln. The Nebraska Chamber of Commerce & Industry Scholarship was awarded to Kristen Otterson of the University of Nebraska-Lincoln. ■

## State Chamber Views...

# “RISK MANAGEMENT”

**R**isk management is a time honored tool regarding a business' ability to judiciously accomplish the task of lowering exposure to possible loss or danger. Nebraska, as well as the rest of the nation, has just experienced a time of high economic danger and some loss.

Fortunately, Nebraska policy-makers practiced better risk management than some other states. The risk management that I write of was the foresight of the Nebraska Legislature to create economic incentives that promoted new investments, retooling and greater diversification of our economy. Yes, businesses did have to make some tough cuts and suffer some job losses over the past four years. But, when compared to the recession of the early 1980's, it does appear that we have weathered this storm somewhat better.

Are we in the clear with no future worry about economic downturns?

### ABSOLUTELY NOT !!!!

Discussions with my counterparts in other states have indeed been interesting.

Neighboring states, like Colorado, kept taxes off the table, but increased dozens of fees on licenses, permits and penalties. Kansas is diverting \$160 million from its highway fund to help pay for the rest of government services.

Nebraska did have to broaden its tax base and increase rates slightly to weather that storm, but according to *CFO Magazine*, states like New Jersey, California, Massachusetts and New York lead the nation in both raising taxes and creating a tax structure that is less fair and predict-

able. These same states were also cited as among the most likely to eliminate or reduce existing business tax incentives this year.

A leading site selection magazine, *Area Development, Site and Facility Planning*, just released its factors on why businesses pick locations for expansion. “**State and local incentives**” were number one on the list. In addition, “tax exemptions” was number six and “corporate tax rates” was number seven. Items like “labor cost,” “availability of skilled labor” and “construction cost” also ranked in the top five.

Incentives have now become the most critical factor in attracting both job and investment growth. It is a very competitive world now, and states need every effective tool available. Although a positive tax climate and work ethic is good, it is often not good enough.

Now is not the time to expose our future potential economic growth with added risk. Increased risk would entail the repeal or weakening of the very economic incentives that grew and diversified our economy during the 1990's. Now is the time to strengthen them. It is time to look at the next generation of incentives to assure future generations of Nebraskans with job opportunities.

Nebraska was one of only two states to record the creation of more higher-paying jobs in recent years, a study from the Economic Policy Institute says. Besides Nebraska, only Nevada recorded the creation of more higher-paying jobs, said the nonprofit, nonpartisan think tank. Nationwide, industries that are gaining jobs relative to industries that are losing jobs pay 21% less annually. In Nebraska, that

number is 4% more. This would indicate that we are not only growing jobs, we are growing good jobs.

As we have done in recent years, we can look for ways to assure competitive wage levels and reasonable and meaningful disclosure of economic growth and job creation laws that do not expose proprietary information or disclose company-specific tax returns and contract information. That would only hinder the competitiveness of expanding Nebraska companies.

We also need to look at attracting technology-based industries — new generations of high tech and bio-med firms — that current incentives do not address adequately.

There are those who believe that job creation, investment and economic growth are not important for Nebraska's future. Whether you like tax incentives or not is not relevant. The attraction of jobs is extremely competitive, not only in our country, but throughout the world. Tax incentives are the most direct method to encourage business investment and job growth. The consequences for any state that does not respond to this challenge are economic stagnation, lower tax and fee revenues and reduced opportunity for its citizens. ■
